With reference to the subject mentioned above, I am directed to inform you that Letter of intent has been issued to the Colleges by Medical Assessment and Rating Board for Indian System of Medicine on dated **04.10.2021, 05.10.2021 and 07.10.2021.**

Further it has been observed that due to oversight in Para no 4 and 5 it has been mentioned that:

4. The college administration is to ensure that no student is admitted in the UG (BAMS) course till the formal permission by issue of Letter of Permission (LOP) of the Central Government is granted.
5. The Medical Assessment and Rating Board for Indian System of Medicine (NCISM) will visit the college virtual or physical to verify the compliance of the fulfillment of the above conditions by the applicant and recommendations for issuing/not issuing the LOP will be furnished to the Central Government.

Which will be read as under:-

4. *"The college administration is to ensure that no student is admitted in the UG (BAMS) course till the formal permission i.e. Letter of Permission (LOP) is granted.*
5. *The Medical Assessment and Rating Board for Indian System of Medicine (NCISM) will visit the college virtually or physically to verify the compliance of the fulfillment of the above conditions by the applicant and issuing/not issuing the LOP will be Considered. "*
